5. Fancher Creek – City of Fresno – Community Facilities District:

- a. Executive Director Barna informed the Commission that a detailed itinerary regarding the November CSCDA Fall Meeting will be emailed out soon.

Rob Pierce, COO of the CSAC Finance Corporation, announced that after thoughtful conversation and deliberation, the CSAC Executive Committee appointed Vito Chiesa (Supervisor Stanislaus County) and Leonard Moty (Retired Shasta County Supervisor) to the CSCDA Commission, replacing the long-standing Commissioners Dan Mierzwa and Tim Snellings. These two appointments, pursuant to the action, are effective November 1, 2024. Rob expressed his gratitude to Dan and Tim for their years of service to CSCDA. The CSAC Executive Committee will be reviewing its appointments each year with the goal of maintaining staggered three-year terms for all four commissioners and the alternate, assessing them annually in October in advance of the Fall CSCDA meeting.

PURPOSE: Consent Calendar

1. Consideration of a resolution approving the First Supplemental Master Pledge Assignment in connection with the Citrus Manor Apartments, City of Susanville, County of Lassen, California.

The bonds financed a mortgage loan to the developer of Citrus Manor Apartments. The developer has requested an extension of the maturity date up to sixteen months, and modifications to the prepayment and redemption provisions. The modifications will allow additional time for the developer to prepay the loan and redeem the outstanding bonds in connection with the refinancing of the project.

2. Consideration of resolution to initiate commercial PACE foreclosure proceedings relating to Laurel Creek, LP, City of San Luis Obispo, County of San Luis Obispo, California.

In 2020, CSCDA issued \$9,500,000 in commercial PACE bonds for Laurel Creek which is a commercial/industrial project in San Luis Obispo (the "Project"). The Project is delinquent on its last PACE installment and has been removed from the tax roll. Petros is the PACE Administrator and bondholder and has requested the initiation of foreclosure proceedings. Stradling is CSCDA's foreclosure counsel for these matters. All legal fees are borne by Petros. Recommend approval.

BACKGROUND AND SUMMARY:

The actions requested today by the Commission are the first steps in connection with the 8 assessment district projects expected to be included in the SCIP 2024C-2 pool. The remaining CFD projects will be considered at the November 7, 2024 meeting. Attachment A includes a breakdown and location of the projects. The estimated total amount of the SCIP 2024C-2 financing is \$28 million.

The resolutions/notices include the following actions:

- a. Resolutions of intention in respect of the ADs to finance capital improvements and/or the payment of development impact fees for public capital improvements, including approval of proposed boundary maps;
- b. Resolutions preliminarily approving the engineer's reports in respect of the ADs, setting date for the public hearing of protests and providing for property owner ballots.

Subsequent approvals of the financing will be brought back to the Commission at future meetings.

RECOMMENDED ACTION:

CSCDA's Executive Director recommends approval of the resolutions as presented to the Commission and setting the public hearing for December 19, 2024 at 2:00 pm.

PURPOSE: Consideration of a Joint Exercise of Powers Agreement between CSCDA and San Benito County Water District.

EXECUTIVE SUMMARY:

The San Benito County Water District (the “County”) has requested that CSCDA enter into a new joint exercise of powers agreement, creating the San Benito County Water District Financing Authority (the “Authority”), to assist with the financing of water capital improvement projects for the District.

BACKGROUND & SUMMARY:

In order to form the joint powers authority, the District needed to find an eligible public entity to be the counterparty to a joint exercise of powers agreement.

- The governing board of the Authority will consist of the members of the District Board. The administration and operation of the Authority will be provided by District staff.
- CSCDA will be the only other member to the Authority. Standard limitations on liability and indemnification are contained in the Joint Exercise of Powers Agreement between the District and CSCDA.
- CSCDA has previously entered into similar joint powers agreements to assist the San Bruno Park School District, Cameron Park Community Services District, San Dieguito Union High School District, Alameda County Flood Control and Water Conservation District, Zone 7, City of Orange, City of Martinez, West County Wastewater District, City of Dublin, Mountain House Community Services District, El Toro Water District, City of St. Helena, City of Laguna Beach, City of Santa Barbara, Hidden Lakes CSD, Laguna Beach County Water District and City of Goleta in connection with similar financings.
- CSCDA will charge the District its standard facilitation fee of \$10,000.

- Jones Hall is serving as bond counsel. CSCDA's General Counsel has reviewed the Joint Exercise of Powers Agreement.

RECOMMENDED ACTION:

CSCDA's Executive Director recommends that the Commission approve the resolution to authorize CSCDA to enter into the joint exercise of powers agreement by and between CSCDA and the San Benito County Water District.

PURPOSE: Consideration of Intellectual Property License, Royalty, and Administrative Agreement

BACKGROUND:

Since the inception of CSCDA, the Authority has enjoyed the sponsorship and administrative services from the League of California Cities (“LCC”) and the California State Association of Counties (“CSAC”) (“Associations”). The Associations have provided valuable intellectual property, direct services, and resources to ensure accountability and continued success of CSCDA and its programs which are of considerable benefit to the public and the Associations’ members. A portion of CSCDA’s revenues have been provided to the Associations. The Associations use the revenues to provide education, training and advocacy services to cities and counties. Such services provide substantial public benefits to the people of California by helping to lower the dues paid to the Associations by cities and counties, strengthening city and county governments in California, providing elected and appointed officials with vital information, management, and governance tools, and promoting the dissemination of information about “best practices” in local government.

DISCUSSION:

CSCDA’s original Agreement with LCC and CSAC was entered into on June 1, 1988. It was replaced by an Intellectual Property License, Royalty, and Administrative Agreement on July 1, 2015, which expires on December 31, 2024.

The 2015 Agreement established the terms for the use of LCC and CSAC trademarks and identified the services LCC and CSAC provide to CSCDA which include providing meeting space, taking minutes for Commission meetings, executing documents on behalf of the commission, providing legislative services, and program development services. The LCC and CSAC agreed to provide additional services which included account administration, administrative services to the CSCDA Executive Director, and additional document execution services in connection with CSCDA’s Property Assessed Clean Energy (“PACE”) Programs.

CSCDA is obligated to pay the Associations a Royalty Fee representing compensation for the intellectual property and related services provided to CSCDA. The Royalty Fee represents the Authority's net revenues after funds are allocated to the Authority's Reserve, Program Manager(s), and after funds are allocated to the Authority's Operating Sub-Account. The Authority's net revenues are allocated 50% to the LCC and 50% to CSAC.

The proposed Administrative Agreement includes minor changes compared to the 2015 Agreement. Certain language has been clarified and a section with the definition of certain terms has been added. The 2015 Agreement included definitions by reference to the Program Manager Agreement with BSP.

The term of the new agreement will expire on December 31, 2027, with automatic renewals for successive two-year terms until December 31, 2031, unless terminated with 90 days' notice prior to the end of the then current termination.

Executive Director Recommendation:

The Executive Director recommends that the Commission approve the Intellectual Property License, Royalty, and Administrative Agreement with the LCC and CSAC.
